With this email, December 23, 2019 at 9:02 PM, I am opening a meeting of Friends of the Taylor Observatory-Norton Planetarium , as provided in the Friends of Taylor-Norton By-Laws.

NEW BUSINESS:

Angelo Parisi of LCOE has presented a plan to upgrade the Digitalis Planetarium system to current software and hardware revisions. In November he visited Digitalis in WA to learn details.

The total upgrade cost is \$17,600 if ordered before January 1, 2020. I will forward the formal quotation shortly (waiting for Angelo).

--- Ten percent price increase after January 1.

Background: With Angelo in charge of day-to-day operations at Taylor the Planetarium system is being heavily used for instruction for K-12 students and for the community Astronomy Course that is now underway (first 6 weeks of 18 completed as of Dec 18). There will be increased planetarium use as LCOE/FOTO proceed with the plan to open Taylor on Friday nights.

In particular, read the "Nightshade" tab and "Educators" tabs.

We can only access these by bringing the Digitalis/Nightshade system, now at least 8 years out of date, to current revisions. The upgrades involve both programs and hardware.

Source of funds:

- -- \$6,000 LCOE. Brock Falkenburg has agreed to fund \$6,000 out of LCOE funds.
- -- Note: Earlier this year LCOE paid \$4,500 for the Meade LX-200 telescope repair and upgrade, now finally paid to Chris Eriksson.

-- \$6,000 from FOTO reserves.

- -- FOTO has generally expected to fund planetarium shows, but the most recent show purchased, Firefall, was bought four years ago; most shows are now rented.
- **Additional \$5,600:** I propose that, after January 1st, we conduct a targeted fundraiser for the planetarium upgrade.
 - -- We have never asked the 75+ members to renew.
 - -- The e-mail list, now at 650, can be solicited for new memberships.
- -- As CEO, I expect to contribute \$500 per year, but have not done so for 3 years. I will now offer \$1,500, which, along with any other contributions from BOD members, might be considered as a "matching donation" in the letter to members and friends.

[I want my own contribution to be in CY 2020 for tax reasons].

[Several years ago, when I took over at Taylor, a letter to a much smaller number of members resulted in contributions of several thousand dollars. We have a solid set of accomplishments to list in the fundraising letter.]

MOTION:
